At Bethlehem Elementary inventions included The BullDog, Louis Gargulio and Francis Cuccia; The Temperature Stickers, Kennedy Amodio, Lyla Johnson, Mae Ambruso; The Never Lost, Camille Sanchez; Painter 2.0, Leighton Parmelee, Lola Kakowski; and the EZ Light, Oliver Nix.

Of these student winners, the state has selected Oliver Nix, Luca Maini, Katie Kulesza and Ava LeBlanc. These students are moving on to the state finals at the University of Connecticut on June 10th. Winners were invited to tell a little bit about their invention.

D. Nonnewaug High School Art Show

A. Curriculum Committee

- 3. On a recommendation by the Curriculum Committee, Jonathan Kapstein moved to approve the AP US History Textbook, "A People and A Nation" 11<sup>th</sup> Edition; seconded by Michael Devine; Michael Devine abstained; all others were aye; motion carried.

Ms. Brown went on record and stated that the district needs to explore alternatives to the textbook due to its hefty cost and weight, offering paperback and/or electronic versions as options.

## 2. Parking Lot Paving at Bethlehem School

Chris Matta made a motion to accept the paving of the parking lot at Bethlehem Elementary School by Asphalt Repair Solutions in the amount of \$207,358.83 as presented; all in favor; none opposed; motion carried unanimously.

### 3. Parking Lot Paving at Mitchell Elementary School

Chris Matta made a motion to accept the paving of the parking lot and Mitchell Elementary School by S&S Paving Inc. in the amount of \$297,203 as presented; all in favor; none opposed; motion carried unanimously.

## 4. Bethlehem Elementary School Playground

Chris Matta made a motion to accept the Playground Option III presented by Creative Recreation from the state bid award in the amount of \$108,077.00; seconded by Jim Crocker; all in favor; none opposed; motion carried unanimously.

# C. Policy Committee

Policy 3542.22 Food Services Personnel Code of Conduct and Policy 3542.41 Food Services Personnel Professional Standards (regulation and appendix also included) were brought to the full Board as a first read.

### D. Safe Schools Committee

Committee Chair, Mike Devine, offered a brief summary from the meeting, which was held on Wednesday, April 19<sup>th</sup>. Topics covered included background checks for elected officials, updates on the ATT Tower and Mutual Link, SRO vehicles and a review of the

October minutes. Discussions also included grants, district safety plans, evacuation drills and a reporting data system for SRO officers.
