

# Register with **anthem.com** for online b access to your benefits.b

Here are step-by-step registration instructions:b

1. From any computer with Internet access, type b **anthem.com** in the Web browser address field.b
2. Click the “Register” button in the Log In area.b
3. Enter your personal information, including member b identification number, first and last name, and date of birth b (mm/dd/yyyy). For security purposes, you will also be asked b to accept terms of use and then insert the secret code b that is displayed. Click “Continue.”b
4. You will then create your username and password. b Next, you will select a security question and provide the b corresponding answer. You will be prompted to answer your b security question if you forget your password. **Please keep w this information in a secure place.** Insert your e-mail b address to receive communications electronically from us. b If you would like to receive additional e-mails regarding special offb and new product information, check the box. Click “Continue.”b
5. If you have prescription coverage with Anthem you can b select the medications you are allergic to and the medical conditions you have. Include b a daytime telephone number to be contacted if prescription questions come up. Click “Continue” and “Confirm.”b
6. Lastly, for security purposes, confirm your username and password, choose “Log In” to begin taking advantage b of online access to your benefits.b
